## 8 Conclusions

In this paper we proposed a new mixture of models class based on smooth transition regression trees. A quasi-maximum likelihood estimator was developed and its asymptotic properties were derived under mild regularity conditions. A model building strategy was also considered. Monte Carlo simulations gave strong support for the theory developed here, even in small samples. Two applications with real data were used to illustrate the model.
